CITY OF SOUTHAMPTON

Made under Section 68 of the Town Police Clauses Act 1847 and Section 171 of the Public Health Act 1875 by Southampton City Council with respect to Hackney Carriages in the City of Southampton.

Byelaw No.17 with respect to Hackney Carriages made by Southampton City Council on the 13th September 1979 and confirmed by one of Her Majesty's Principal Secretaries of State on the 28th December 1979 is hereby repealed and replaced by the following byelaw which should be read, and construed as one with the series of Byelaws made by the Mayor, Aldermen and Citizens of the City of Southampton acting by the Council on the 15th June 1970 and confirmed by one of the said Principal Secretaries of State on the 21st September 1970:-

17 - Provisions fixing the stands of Hackney Carriages.

Each of the several places specified in the following list shall be a stand for such number of hackney carriages as is specified in the list:-

Above Bar Street - east side, from a point 55 metres south of its junction with Brunswick Place southwards for a distance of 31.5 metres.	7
Bargate Street - north side, from a point 15 metres east of the junction of Portland Terrace eastwards for a distance of 31.5 metres.	7
Bedford Place - west side, from a point 13 metres north of the extended northern kerbline of Waterloo Terrace southwards for a distance of 27 metres.	. 6
Blechynden Terrace - south side, from a point 14 metres east of the extended eastern kerbline of Wyndham Place westwards for a distance of 27 metres.	6
Church Street - east side, from a point 21 metres north of its junction with Shirley High Street northwards for a distance of 26 metres.	.5

Ogle Road - south side, from a point 8 metres west of its junction with Above Bar Street westwards for a distance of 36 metres and from a point 48 metres west of its junction with Above Bar Street westwards for a distance of 4.5 metres.			9
Portsmouth Road - south side, from a point 117 metres east of eastern kerbline of Johns Road eastwards for a distance of 9 metres.			2
Queensway - west side, from a point 36 metres north of the northern kerbline of East Street northwards for a distance of 13.5 metres.			3
St. Michael's Street - north side, from a point 9 metres east of its junction with Castle Way eastwards for a distance of 36 metres.			8
