Any representation must relate to at least one of the licensing objectives. Frivolous or vexatious representations are likely to be rejected.

Please note that it is an offence knowingly or recklessly to make a false statement in connection with an application and, on summary conviction for the offence, a person is liable to a fine not exceeding level five on the standard scale (currently £5000).

The Chief Officer of Police makes this application for review, after being satisfied that the PLH and DPS (Same person) that after conviction of a relevant offence, namely "Sexual assault, intentionally touch a female under 16, contry to section 3 of the sexual offences act 2003".

Sudhir PATIL of 97 Vanguard Road, Southampton, SO18 2EH, is the current sole director of the company that holds the premises licence and he is also the DPS at the same property.

Idox Annotate

Patil was convicted on the 25/06/24 at Southampton Crown Court of the above offence, he was fined £2000 and made to pay compensation of £500, cost £1000, victim surcharge £800 and placed on the sexual offenders register for a period of 5 years.

The offence as despicable as it is, took place with in the licensed premises above where it should be reasonably accepted to be considered a place of safety.

Please see attached Police National Computer report of the conviction, Sexual Offender Registration Order.

The Chief Officer of Police, is satisfied following conviction for the above results in Patil having failed in his responsibility to up hold the licensing objectives, Prevention of Crime and disorder, Public Safety, and more over considering the offence was against a child, the Protection of Children of Harm.

Therefore the premises licence should be revoked in its entirety, as no amount of conditions can prevent this crime from occurring again.
