BYELAWS

Made under Section 164 of the Public Health Act, 1875, Sections 12 and 15 of the Open Spaces Act 1906 by Southampton City Council with respect to Pleasure Grounds.

1. The Series of Byelaws with respect to Pleasure Grounds made by the Council on 12th April 1967 and confirmed by the Secretary of State on 31st July 1967 as amended by Byelaws respectively made by the Council on 26th July 1977 and 28th July, 1981 and the 9th October 1985 is hereby further amended and extended as follows:-

- (1) The Proviso to paragraph (ii) of Byelaw 6 shall be deleted and the following substituted:-

"Provided that paragraphs (i) and (ii) of this Byelaw shall not apply to the Common and provided that the said paragraph (ii) shall not apply to those paths, cycleways, roads and other routes specified in the Second Schedule to these Byelaws".

- (2) The Schedule to the aforesaid series shall be renamed "the First Schedule" and the word "First" inserted before the word "Schedule" in paragraph (iii) of Byelaw 6.
- (3) A Second Schedule in the following terms shall be added at the end of the aforesaid series:

"THE SECOND SCHEDULE"

Paragraph (ii) of Byelaw 6 does not apply to the following:-

- (1) Any path, road or track on Lord's Hill Sports Centre which is designated and clearly marked as a cycleway by the Council.
- (2) On Weston Shore Park the surfaced path that leads from the southern end of Victoria Road to the junction of Weston Lane and Weston Parade".

2. These Byelaws may be cited as the City of Southampton Pleasure Grounds (Cycle Provisions) Byelaws 1985.
