CONDUCT OF MEETING

Rules of Procedure

The meeting is governed by the Council Procedure Rules as set out in Part 4 of the Constitution.

Business to be discussed

Only those items listed on the attached agenda may be considered at this meeting.

Quorum

The minimum number of appointed Members required to be in attendance to hold the meeting is 3.

CONDUCT OF MEETING

DISCLOSURE OF INTERESTS

Members are required to disclose, in accordance with the Members' Code of Conduct, **both** the existence **and** nature of any "Disclosable Pecuniary Interest" or "Other Interest" they may have in relation to matters for consideration on this Agenda.

DISCLOSABLE PECUNIARY INTERESTS

A Member must regard himself or herself as having a Disclosable Pecuniary Interest in any matter that they or their spouse, partner, a person they are living with as husband or wife, or a person with whom they are living as if they were a civil partner in relation to:

(i) Any employment, office, trade, profession or vocation carried on for profit or gain.

(ii) Sponsorship:

Any payment or provision of any other financial benefit (other than from Southampton City Council) made or provided within the relevant period in respect of any expense incurred by you in carrying out duties as a member, or towards your election expenses. This includes any payment or financial benefit from a trade union within the meaning of the Trade Union and Labour Relations (Consolidation) Act 1992.

(iii) Any contract which is made between you / your spouse etc (or a body in which the you / your spouse etc has a beneficial interest) and Southampton City Council under which goods or services are to be provided or works are to be executed, and which has not been fully discharged.

(iv) Any beneficial interest in land which is within the area of Southampton.

(v) Any license (held alone or jointly with others) to occupy land in the area of Southampton for a month or longer.

(vi) Any tenancy where (to your knowledge) the landlord is Southampton City Council and the tenant is a body in which you / your spouse etc has a beneficial interests.

(vii) Any beneficial interest in securities of a body where that body (to your knowledge) has a place of business or land in the area of Southampton, and either:

a) the total nominal value of the securities exceeds £25,000 or one hundredth of the total issued share capital of that body, or

b) if the share capital of that body is of more than one class, the total nominal value of the shares of any one class in which you / your spouse etc has a beneficial interest that exceeds one hundredth of the total issued share capital of that class.

Other Interests

A Member must regard himself or herself as having an, 'Other Interest' in any membership of, or occupation of a position of general control or management in:

Any body to which they have been appointed or nominated by Southampton City Council

Any public authority or body exercising functions of a public nature

Any body directed to charitable purposes

Any body whose principal purpose includes the influence of public opinion or policy

Principles of Decision Making

All decisions of the Council will be made in accordance with the following principles:-

- proportionality (i.e. the action must be proportionate to the desired outcome);
- due consultation and the taking of professional advice from officers;
- respect for human rights;
- a presumption in favour of openness, accountability and transparency;
- setting out what options have been considered;
- setting out reasons for the decision; and
- clarity of aims and desired outcomes.

In exercising discretion, the decision maker must:

- understand the law that regulates the decision making power and gives effect to it. The decision-maker must direct itself properly in law;
- take into account all relevant matters (those matters which the law requires the authority as a matter of legal obligation to take into account);
- leave out of account irrelevant considerations;
- act for a proper purpose, exercising its powers for the public good;
- not reach a decision which no authority acting reasonably could reach, (also known as the "rationality" or "taking leave of your senses" principle);
- comply with the rule that local government finance is to be conducted on an annual basis. Save to the extent authorised by Parliament, 'live now, pay later' and forward funding are unlawful; and
- act with procedural propriety in accordance with the rules of fairness.

7. **APPLICATION FOR VARIATION OF A SEXUAL ENTERTAINMENT VENUE LICENCE - WIGGLE, 188 ABOVE BAR STREET**

The Sub-Committee considered the application for the variation of a Sexual Entertainment Venue Licence in respect of Wiggle, 188 Above Bar Street, Southampton SO14 7DW.

Jaspal Ojla (applicant) and Anthony Horne (applicant's legal representative) were present and with the consent of the Chair addressed the meeting.

RESOLVED that the variation of a Sexual Entertainment Venue licence to extend the permitted hours and to amend the internal layout of the premises, as specified in the application, be approved.

Reasons

The Sub-Committee noted that:

- The applicant had held a Sexual Entertainment Venue licence in Southampton since 2nd January 2016 when the licence had transferred under delegated powers without objection.
- That the licence was renewable annually and that the licence would therefore be up for renewal in February this year.
- The premises licence under the Licensing Act 2003 was varied on 30 December 2015 without objection, to extend regulated entertainment until 06:00, and provision of late night refreshment and the supply by retail of alcohol until 05:00.
- The applicant operated other premises under Sexual Entertainment Venue licences in Bournemouth and Portsmouth and had done for a considerable period.

- The application was made following consultation with and without objection from the local Constabulary.
- The variation would bring the operation of the premises into line with other premises operating in the City.
- The applicant had exceeded statutory requirements for the variation of a Sexual Entertainment Venue Licence by advertising in the local press and by serving a copy of the proposed variation on Hampshire Constabulary and that neither Hampshire Constabulary nor any other party had raised objection.
