The proposed operating model will help deliver a "strengths-based" approach to social work practice. Instead of looking at residents as a collection of needs and problems, the council will view everyone as unique individuals who have strengths, assets, gifts and talents. The council's aim is to support people to live the best life they can, rather than fitting them into an inflexible range of traditional and expensive services. Appendix 2 explains this in more detail, with an operating model that proposes carrying out assessments, where appropriate, in community cluster hubs. Consultation with staff, trade unions and other stakeholders on a proposed restructure of the council's adult social care teams to deliver this new way of working is currently underway and closes on 22 November 2017.
