

# Legal Implications

The legislation specifically restricts the grounds on which the sub-committee may refuse an applicati for grant of a premises licence, or impose conditions. The legislation provides for a presumption of grant of an application for a premises licence, subject to the determination of the application with a view to promoting the licensing objectives in the overall interests of the local community. In doing so the sub-committee must give appropriate weight to:

- the steps that are appropriate to promote the licensing objectives;
- the representations (including supporting information) presented by all the parties;
- · its own statement of licensing policy
- the Statutory Guidance

An application may be refused in part and thereby only permit some of the licensable activities sought.

An applicant for grant of a premises licence whose application has been refused, or who is aggrieved by conditions imposed, may appeal against the decision to the Magistrates' Court. Any other person, who made a valid representation, may appeal to the Magistrates' Court against the decision to grant the application or against any conditions imposed.

In considering this application the sub-committee is obliged to consider the application in accordance, in particular, with both the Licensing Act 2003(Hearings) Regulations 2005 (as amended) and the rules of natural justice

The practical effect of this is that the sub-committee must make its decision based on evidence submitted in accordance with the legislation and give adequate reasons for reaching its decision.

Only persons that made relevant representations or their representative, within the time limits, will be allowed to present evidence and this will be restricted to the points raised in their written representation. Any evidence used to expand upon specific points already raised in a written representation should be served upon all parties in good time before the hearing date in order to allow proper consideration. A failure to properly serve any such additional evidence in advance is likely to mean it cannot be produced or relied up at the hearing.

The sub-committee must also have regard to:

The Crime and Disorder Act 1998

Section 17 of the Crime and Disorder Act 1998 places the sub-committee under a duty to exercise its various functions with due regard to the likely effect of the exercise of those functions on, and the need to do all that it reasonably can to prevent, crime and disorder in its area.

#### • The Human Rights Act 1998

The Act requires UK legislation to be interpreted in a manner consistent with the European Convention on Human Rights. It is unlawful for the sub-committee to act in a way that is incompatible (or fail to act in a way that is compatible) with the rights protected by the Act. Any action undertaken by the sub-committee that could have an effect upon another person's Human Rights must be taken having regard to the principle of proportionality - the need to balance the rights of the individual with the rights of the community as a whole. Any action taken by the sub-committee which affect another's rights must be no more onerous than is necessary in a democratic society. The matters set out in this report must be considered in light of the above obligations.

Copies of the application for grant of a premises licence and the representations to it are annexed to this report.

### **Equality Act 2010**





We object to this application.

We are residents of Southampton (36e Castle Way, Old Town, Southampton. SO14 2AW) and one of us, Andrew, works near to the Old Cemetery at Cambridge Road, SO14 6US.

It's difficult to know the full details of this application with it not being on the website thanks to the dubious and definitely unhelpful statement, "This licensing application is no longer available for viewing. It may have been removed or restricted from public viewing," so we're only going off a screenshot captured by the Oakmount Triangle Residents Association (and thank you OTRA for bringing this to others' attention).

Where do we begin with a licence for the sale of alcohol and live & recorded music in a cemetery?

Further, a cemetery that, thanks to being a place of quiet reflection, is an extraordinary haven for small mammals and birds, at least two of which are on the Red list of greatest conservation concern, namely the greenfinch and the mistle thrush, as well as numerous species on the amber list.

### It just sounds wrong.

While we are aware that the current custodians of the Design Chapel state that their application is to allow those using their business event space to have a drink while using it, further stating that they do not want or need to sell alcohol. If so, why do they need to apply for a licence for the 'supply by retail of alcohol', let alone ones for 'live music' and 'recorded music'?

We admit that we are not aware of the full range of licensing options and do accept that this might be the only option available to the applicants to ensure that the groups they host can enjoy alcoholic refreshment. However, if granted, is there not a mechanism that can be applied to ensure that the activities taking place in the chapel do not affect those spending time in the cemetery? Otherwise, what is to stop a future custodian of the Design Chapel deciding that, as they have a licence, they can sell alcohol and play music to the full extent of the times requested?

We accept that 3 Men Squared do not wish this to happen but personnel in companies do change and, if this application is allowed, there could easily be groups of people outside drinking and smoking. Hardly appropriate for a cemetery. Even if it were just one person behaving so that would be too many.

Finally, we categorically object to the granting of a licence for recorded and especially live music. It takes little for this to become incredibly upsetting and disturbing. Not only for the precious wildlife the Old Cemetery harbours, but also for those visiting the graves of the recently deceased that are very close to the Design Chapel.

The Southampton Mental Health Network recently conducted a survey of those who reside or work in the city to find out attitudes to making Southampton a mental health friendly city. The importance of access to our open spaces where chances to have those times to wind down were highlighted as a significant benefit to maintain good mental health.

**Crime and Disorder:** The area already has significant challenges to face with regards to high levels of crime and anti-social behaviour. It seems unlikely that this development would improve the situation unless it were linked to a greater police or other security presence.

I would like to object to the above planning application for a drinks and live music application, on the following grounds.

- 1. The chapel is a valued listed building constructed in a Victorian grave yard. The granting of a drinks licence contravenes the hallowed characteristics of the area. This is a cemetery, the final resting place of many citizens of Southampton, and it should not have a purveyor of alcohol amid the graveyard, especially as the chapel is close to the Cross of Sacrifice.
- 2. There is a diversity of wildlife, and flora in the graveyard. This could be adversely affected by the noise and lights emitting from the chapel if the licence is granted. This bio diversity has been largely protected over the years, resulting in a haven for birds, animals, bats, etc, many of whom are nocturnal. Please do not disrupt their habitat.
- 3. The resulting issues with parking and disturbances from noise, possible anti social behaviour as a result of alcohol sales, would have a detrimental affect on the residents living in proximity of the graveyard.



This application is for a music and drinks licence for the Design Chapel in Southampton Old Cemetery.

The Design Chapel is immediately adjacent to the war memorial and is surrounded by grave stones and memorials of buried Southampton citizens from former times. The cemetery has been badly neglected in the past but the volunteer Friends of the Cemetery have made impressive improvements.

The proposed licence activities are an affront to the dignity of those interred and will be an unwanted nuisance for the majority of people who go to the cemetery for quiet walking or to peacefully read the memorials.

The character of the area will be adversely affected for those living in the lodge house, only about fifty yards away from the chapel. The amplified music will likely be a problem for nearby dwellings backing onto the area.

The approach to the cemetery along Cemetery Road is a long recognised cruising ground for casual sex. Rising robbery rates there have required the police to introduce extra patrols. The local availability of booze is only likely to aggravate that situation.

With regard to the above Application (Reference 2021/03910/01SPRN), I am writing to oppose the grant of a license to 3 Men Squared Ltd to use the Design Chapel in the cemetery grounds for the sale of alcohol.

I note that the hours listed for 'Supply by retail of alcohol' are set at seven days a week, from 12.00 to 23.00 daily.

The Chapel in question sits very close to the entrance to this historic cemetery which is a highly-regarded quiet and reflective space where people come to walk among the graves and the trees, some of which remain from the days of an arboretum which was on this site before the building of the cemetery. The extensive grounds of this historic cemetery are partnered by a much smaller but important Jewish cemetery.

The Chapel lies in hallowed ground, in an area which is important historically and today to both Christians and Jews, as well as to people of different faiths or no faith who seek respite in natural surroundings in the heart of a city. The cemetery area as a whole is a welcome refuge from busy roads and busy lives. It was of huge significance during the periods of lockdown as offering the people of Southampton a place to walk and relax in, sometimes daily.

The suggestion of selling alcohol from the heart of the cemetery (the Chapel) for eleven hours a day is an incredible insult to citizens of Southampton. The cemetery is treasured, valued and respected for the very reasons I have given. The Chapel is not an appropriate site for the venture. It is essentially an old religious site not a site for drinking. In addition, the area is quiet and secluded. Leaving a venue at night in a secluded place where drinking of alcohol is available for eleven hours provides a nightmare scenario for women of all ages. How would safe would they be? How would they get home?

Southampton is aiming to bid for 'city of culture' status. I do not feel that opening a place for the sale of alcohol in the grounds of the city's historic cemetery contributes to the

notion of 'culture'. Its secluded site implies dangerous closing times, particularly for women, who will be trying to get home through darkened lanes.

I would like to object to the application for a live and recorded music licence at the Design Chapel on Cemetery Road on the grounds of the prevention of public nulsance.

This building is in Southampton Old Cemetery. This is a peaceful area used by a large number of local residents and those further afield to provide a quiet area for rest and relaxation. It is difficult to find such peaceful spots in Southampton, which are so essential to our mental health, particularly during the current pandemic. Any music noise will remove that ability of the area to help one escape from the stresses of modern life.

As stated by the community organisation The Friends of the Old Cemetery one of their main aims is to 'uphold the original purpose of the cemetery, which is to be a place of reflection and remembrance of the people buried there.' This original purpose of the area to be a place of quiet reflection for those who have lost loved ones should be respected and not interrupted by music from a commercial 'venue'.

I have no objection to the use of the building as an office space, but unfortunately music does not stay within the confines of the building and while providing entertainment for a few and income for the company hiring the space out, it entirely removes the essential resource of peace and quiet for the entire community.

While in the application it is stated that the building has thick walls and no ground floor windows this does not prevent music coming through an open door. On the website <a href="www.ichapel.co.uk">www.ichapel.co.uk</a> the building is advertised as 'surrounded by 27 acres of cemetery which has special scientific interest (SSI) status and sits at the southern end of the 326 acres of Southampton Common, an unrivalled outdoor space at your disposal'. This shows clear intent that 'gatherings' at the design chapel are not intended to be contained within the building (see attachment A). They also have photos on the website showing outside table and chairs (attachment B). With such advertising anyone hiring the chapel will not be expecting to contain their event inside a closed building and thus any music will be heard throughout the cemetery. (NB removing these items from the website would

not remove the intent of the hire company)

Much as it may seem entrepreneurial to reuse the chapel, the way the Chapel is reused needs to be sensitive to the essential needs of the local community. This is not a city centre site and the unique, very special atmosphere of the Old Cemetery should mean no music is allowed. There are plenty of venues allowing music in Southampton, but very few providing quiet.

With regard to the above Application (Reference 2021/03910/01SPRN), I am writing to oppose the grant of a license to 3 Men Squared Ltd to use the Design Chapel in the cemetery grounds for the sale of alcohol and for live or recorded music, seven days a week, from 12.00 to 23.00 daily.

Southampton City Council, describes on its website managing 'peaceful cemeteries' and providing a 'peaceful place for quiet reflection' and to 'keep noise to a minimum' and 'be respectful to others visiting graves'. These commitments should be respected and safeguarded, the presence of live and recorded music, with alcohol sale daily from 12-23.00 daily does not fall into a peaceful category of management. English Heritage also supports this, noting that historic cemeteries are often complex sites rich in architecture and sculpture and wonderful wildlife habitats and 'most importantly they are places for commemoration and remembrance, and for those mourning' — so not a place for the sale of alcohol and for live or recorded music, seven days a week, from 12.00 to 23.00 daily. The statutory licensing objectives on your website for valid objections are stated as: prevention of crime and disorder, public safety, the prevention of public nuisance, and the protection of children from harm. I believe that this objection engages with each of those factors.

In a guide to the management plan for Southampton Common, it is noted that the key principles for management of the common, of which the cemetery is part, is for 'improving community safety and reducing crime and disorder' as key priorities. It also notes the historical importance and conservation management approach for the great diversity of wildlife and fauna which should be protected and not disturbed. The presence of live and recorded music with daily sale of alcohol from 12-23.00 daily poses a risk to these key priorities, and to the safety of families, children and women when visiting the cemetery for its true purpose, safely and peacefully.

As stated on the website, 'all visitors to the cemetery must behave in a respectful manner' especially with its continuing use as a burial ground, and the proposal for the sale of alcohol and for live or recorded music, seven days a week, from 12.00 to 23.00 daily, within this sacred burial ground, is not aligned with the respectful purpose and function of the cemetery, especially those families with loved ones buried there, and the children and families being at peace to remember while being safeguarded.

Looking online, many cemeteries have safeguarding policies, for example the Highgate Cemetery Safeguarding Policy, that 'prioritises providing a safe environment for any child, young person or adult visiting or working' at the cemetery and 'this includes a commitment to protecting vulnerable adults and children'. This confirms the purpose of cemeteries, including the Southampton Cemetery, as common and hallowed ground that should be suitable for families, children and vulnerable people in a way that respects the

cultural, environmental and historical heritage, and it feels critical for Southampton City Council to bring together a safeguarding policy for the cemeteries that are under their 'peaceful management'.

Especially in light of recent national events, it feels appropriate to encourage a place of safety for families, children, those who are vulnerable, and women, and to safeguard the purpose of the cemetery for which a licensing application has been made, as a place for the bereaved and preserving safety of sacred grounds.

In addition, the cemetery provides a place of refuge for peace and reflection and appreciation of nature in the middle of a busy and noisy city, and this offers great value to families and vulnerable people, especially in these times of Covid-19, and is an asset that is aligned with the proposal of Southampton as a City of Culture and should be protected as such.

For all these reasons, supported by the messaging of Southampton City Council itself, I write to oppose the grant of a licence and would value further protection for Southampton's cemeteries through a 'Safeguarding Policy' that retains the purpose and protection of the grounds and buildings, and prioritises the safety of families, children and vulnerable people, respecting the hallowed ground and continuing use as a burial site. Our sincere apologies for getting this objection to you on the deadline, however there was no official notification to local and neighboring residents in regard to this application (which I'm sure you're supposed to do) and we only found out about it because someone in the neighborhood sent it to us last night. Given the fact that local residents have only just been made aware of this request, can we extend the deadline for responses by a week?

# Objections from a personal objective

We are residents who live at 32 Atherley Court and our house is directly opposite the entrance to the old cemetery on Hill Lane, with our bedroom walls closest to the road.

I work from home, my mum is 70 years old and a carer for people with Learning Disabilities. We have a girl with Learning Disabilities who lives with us and frequently we have other guests with Learning Disabilities on respite that mum cares for.

We value highly that we live in a reasonably quiet residential area, except the traffic noise from Hill Lane. On occasion, when either the Common or the Bowling Club host events the noise travels, quite aggressively into our homes, however this is tolerable because they are occasional events.

We are therefore very concerned about necessary residential peace and quiet being disturbed on a 7-days-a-week basis with both recorded or live music from 12.00 until 23.00 as well as the additional noise of people using the cememarty entrance until 11pm each night, especially if they've been drinking and are therefore even more noisy.

I have recently moved to Southampton from London and can't express how much I value the peace and quiet of this area and especially The Common and Old Cemetery, it really breaks my heart that such a request is being made to potentially ruin this beautiful and peaceful corner of our city.

SCAPPS objects to a premises licence being granted for sale of alcohol and performance of live and recorded music at the former Anglican chapel in Southampton Old Cemetery. The Old Cemetery is 'of more than special interest'; it's listed II\* in the national Register of Parks and Gardens of Special Historic Interest. Immediately in front of the chapel, adjacent to its entrance door, is a War Memorial — a Commonwealth War Graves Commission Cross of Sacrifice. The cemetery is still in use. The Anglican chapel is surrounded by memorials commemorating past residents of Southampton, including some significant and distinguished former citizens of the town. Use of the chapel for sale of alcohol and for activities regularly involving performance of live and recorded music is inappropriate, insensitive and disrespectful of the surroundings.

In terms of relating this objection to statutory licensing objectives, SCAPPS submits the proposal conflicts with the objectives of securing public safety and preventing public nuisance. The Old Cemetery is both a place of commemoration and remembrance and also a valued, much-used and appreciated public open space. Both would be adversely affected by grant of a premises licence.

#### Design Chapel, Cemetery Road, Southampton SO15 7AF

As Head of Service for Consumer Protection and Environmental Services and as the Service Manager for Bereavement Services we wish to submit an objection to the following licensing application. We consider this application will not be in the interest of Public Safety and The Prevention of Public Nuisance.

The lease dated 28 July 2002 stipulates under "User" 4.5.8; that the premises are not be used for the purpose of (d) "for the sale of alcoholic drinks or any similar purpose" and (e) "any purpose or in any manner which shall be inconsistent with a previously consecrated building situated within a cemetery" and (f) any use which is in the reasonable opinion of the Council will become a nuisance, annoyance or disturbance to users and visitors of the cemetery and occupiers of adjacent properties".

#### The prevention of Public Nuisance

The Conformist Chapel at Southampton Old Cemetery is situated within the grounds of the cemetery immediately behind the Cross of Sacrifice, which signifies that, within the cemetery, there are burials from both World Wars, the cross to the design of Sir Reginald Blomfield, one of the Imperial War Graves Commission's architects, was placed there after the First World War and each year on Remembrance Sunday have wreaths laid to remember all war dead. The chapel is also very close to burials and headstones of unique interest such as the Pearce Memorial and Grade II listed structure, with its fine sculpture representing Faith, Hope and Charity over the grave of Robert Pearce, a banker who died in 1861. General Juan Manual de Rosas memorial which is featured on FOSOC guide walks, the memorial of Captain George Smith R.N. who died in 1850 is a unique memorial featuring an upside-down boat, representing a paddle box lifeboat to commemorate the first commander of HMS Excellent the Royal Navy School of Gunnery at Portsmouth and the Boer War Memorial, which are all visited regularly by cemetery users/visitors. The burial areas are designated as consecrated ground so their proximity to this venue is of concern in relation to patrons using this premises not respecting this area.

# Public Safety and The prevention of Public Nuisance

Southampton Old Cemetery is a working cemetery with the Friends of the Old Cemetery (FOSOC) group assisting on a weekly basis with the grounds maintenance during the day alongside the Southampton City Council cemetery operatives. The premises is open to members of the public from 09.00 hours to 23.00hrs seven days a week.

It is further noted that the alcohol licence application will be from 12 noon to 23.00 hrs seven days a week during which times burials could possibly still be taking place of which the Designated Premises Supervisor (DPS) and other authorised persons would not be aware of, as this venue is not operated by Southampton City Council.

Members of the public visiting their beloved ones graves, attending burials and those using the facility to exercise including children, walk daily through the cemetery. This Chapel entrance faces the main cemetery gates from Cemetery Road where most visitors enter. We have concerns about levels of noise and the unchecked behaviour of visiting public in such a sensitive area. (lease agreement 4.5.8 (f))

#### **Public Safety**

The Southampton Old Cemetery does become an isolated place in the evening with no lighting and it is noted that the licence application is until 23:00 hours seven days a week. If large numbers of attendees use the facility and the Designated Premises Supervisor or any authorised person is not available to ensure that those inside leave in a considerate manner this could result in complaints from any visitors who walk within the cemetery at that time, or indeed from the residents in the Lodge. With no lighting within the cemetery, trips or falls could occur due to the uneven ground and sunken graves and memorials.

#### The Prevention of Public Nuisance

The rubbish bins, emptied by the cemetery operatives weekly, are small and not suitable for the disposal of bottles or any additional rubbish that these events could produce.

As this is a working cemetery is it considered the incorrect place for alcohol to be served. There is the additional concern that during the warmer days/evenings that attendees at these business events take their drinks outside, especially if the DPS is not available onsite to "police" their activities.

#### **The Prevention of Public Nuisance**

Due to the proximity of the graves and memorials around this venue it would be of concern that these could be vandalised and or these areas used in a disrespectful manner.

I have recently learnt of the licensing application for the above premises - the Chapel in the Old Cemetery. I was very concerned to hear this and although i do not live immediately adjacent I do walk often on the Common, including through the Old Cemetery. It is a place of peace and calm and nature- a haven for local residents and one that has been particularly important in these last two stressful years.

I wish to object specifically on two grounds:

Public Safety and

The Prevention of Public Nuisance

It is really hard to envisage how the granting of an alcohol licence to a place of such character in such a particularly quiet and religious/spiritual location could not contravene issues of public safety and prevention of public nuisance. Any licence at all would encourage a level and type of activity which would be quite out of keeping with this special location. Customers who would be attracted for events including those with a licence would not be visiting this place for the purpose for which it was designed or for the peaceful activities linked to well being for which it is now used. Licenced and entertainment activities are far more likely to produce noise and behaviour of an anti social nature which would certainly disturb the current atmosphere and tranquility of the cemetery and its Surrounds.

The hours which are suggested are long, increasing the likelihood of public nuisance and potentially a risk to the safety of others who are seeking to use the area for walks with family, friends or indeed alone. This is also a precious and historic part of the city's heritage. How can this be protected from nuisance and kept safe? Will the area be patrolled at all opening hours to ensure behaviour is appropriate and that others and historic legacy are protected? Including from litter and post drinking misuse! It would seem unlikely?

The potential for overuse because of numbers attracted by a licensed premises is certainly relevant as is the potential for disrespectful, unsafe and upsetting behaviour It just doesn't feel right, respectful, safe or appropriate.

I urge you to refuse this application.

While we acknowledge that the change of use to the chapel some years ago was done very creatively and appropriately, we believe this to be a totally inappropriate application for the following reasons

As a local resident residing at 31 Blenheim Avenue, Southampton SO17 1DW I wish to object to the granting of a premises licence in the above application.

The Common is a place where many people (not just those that live close by) go for rest and relaxation. Many hundreds of people walk, and continue to walk through the Cemetery for solace, contemplation, and exercise. Since the pandemic, and where other spaces have not permitted, hundreds more have come to appreciate its opportunities to meet friends; enjoy the wildlife, play sport and be with families. For myself the Cemetery has become a regular walk — this quiet haven and the opportunity to reflect on Southampton's history and culture in this quiet space is very much appreciated.

When I first saw the request to use one of the Chapels for late night entertainment and alcohol consumption, I thought it must be a mistake. Venues across Southampton and beyond are littered with such venues — available to consumers at all hours of the day and night. Surely such a venue in the middle of this vast, historical green space is inappropriate on so many levels? The impact of such a business on the environment generally, and the potential effect on the graves themselves, the wildlife and foliage as revellers leave the venue after a late night is surely not worth the risk? We are writing regarding a Notice of Application for the Grant of a Premises Licence from 3 Men Squared Ltd, the Design Chapel, Cemetery Road, Southampton SO15 7AF. We object to this Application for alcohol, live and recorded music from 12-11pm on the following grounds:

#### I. It is an inappropriate venue.

The Chapel is located in a cemetery of historical importance with many local family graves and it seems disrespectful. There are benches placed in that area for contemplation and rest and with mental health issues on the rise, having somewhere like this open to the public is incredibly important.. There is no guarantee that patrons would respect the site and its importance. By its very nature a licensed premises, let alone a music venue, will disrupt that quiet contemplation.

Every day many people like to walk their dogs or just go for a walk with friends, enjoying the lack of commerciality that is found elsewhere and enjoying an oasis of peace and nature in the city centre.

#### 2. Safety concerns

After dark this area is known for its drug dealing, late night trysts of various sorts (usually inappropriate!) and an escape route from the police. A licensed premise would exacerbate an already difficult area both for local residents but I would also question the safety of patrons after dark. The consequence could be more problems for the police.

#### 3. Anti-social behaviour and local noise

Both the above would increase when patrons are leaving the premises. There are houses in Northlands Gardens that back onto cemetery road and would bear the brunt of this. Whilst we live further away in Northlands Gardens, any event on the common can be heard, which is nice a few times a year but a daily exit of people from a licensed premise is another matter.

#### 4. Parking

As Northlands Gardens is very close to cemetery road, for those wanting access to the venue from Hill Lane there would likely be an increase in people using it as their car park, as happens during the day for people who work in Grosvenor Square. Having people come back to their cars at 11.30pm, slamming car doors and saying goodnight to each other would cause upset for the local residents. It would be a noise nuisance and create the potential for anti-social behaviour. In Northlands Gardens there are families with young children and teenagers, older people and a number of NHS workers who do shift work – none of whom need the worry of parking or being woken up.

#### 5. Enough other local venues

There is no need for another licensed premise as there is already the Bellemoor, the Cowherds, The Winston, possibly the Blue Keys should it reopen, in walking distance of each other.

A Cross of Sacrifice to remember our war dead is directly opposite the chapel and is the site of various wreath laying ceremonies.

The car park which would be used by patrons of the establishment is in a secluded area which is already the site of some anti social behaviour, for example, burnt out cars and reports of drug related incidents.

The cemetery has already suffered from repeated acts of vandalism - grave markers have been damaged or pushed over - there is an increased likelihood of visitors to the chapel wandering around the cemetery later at night - with alcohol in the mix and the potential for anti social behaviour.

The cemetery is a haven for wildlife - and this in in part due to the peaceful surroundings especially at night. Noise and disturbance later in the evening would deter nocturnal wildlife.

It is sad and surprising to learn that this business thinks so little of the wonderful surroundings they have that they would seek to ruin it for others. The cemetery is a haven for those who are less inclined to enjoy the formality of the Common and is in fact a small nature reserve as well as of course a sacred place - it cannot be viewed as simply a space to accommodate a hospitality venue and should be left to be enjoyed by those who respect it.

I would like to object to the proposed change in the use of the Chapel and submit that the situation itself is unsuitable for such a radical alteration. Attracting people to this extremely special place by offering alcohol, music and possibly entertainment is totally inappropriate in a place of deep spiritual significance. The setting is particularly important as the Cross of Sacrifice stands very nearby and this is essentially a space for reflection, commemoration and remembrance. The proposed conversion would be at variance with the sacred atmosphere and ethos of the surroundings where peace and tranquillity reign at present and where citizens have always found comfort and consolation. I do not think our cemetery should be viewed as a suitable venue for certain activities which would be more acceptable elsewhere.

I am writing with regard to Planning Application Reference 2021/03910/01SPRN Grant of a Premises Licence for the Design Chapel, Cemetery Road, Southampton SO19 7AF.

In summary, I understand from the Notice of Application that the application essentially seeks permission to have live and / or recorded music and supply by retail alcohol between 1200 and 2300 every day. When I looked, the Licensing Application details were no longer available for viewing (even though the period for responding was still open, on 12<sup>th</sup> December 2021) so there may be information I have not seen. However, I do note that the redacted application form from '3 Men Squared Limited' seeks permission to start the licence on 1 January 2022 and specifies in Section E the times of 1200 to 2300 for live music, the same in Section F for recorded music and in Section J for Supply of Alcohol; in addition, the premises will / may be open from 0900 each day to the public.

In accordance with the Representations page on the Council website, my objection to this application relates to the licensing matters of public safety and the prevention of public nuisance. I accept that the need to protect children from harm is unlikely to be an issue. In addition, I pose a question at the end in order to express my feeling that there are other grounds for comment / objection outside the scope given, and to ask what the appropriate route for submitting these objections is.

On the grounds of public safety, as well as disorder (and damage to property, which may or may not constitute a crime), I feel that the nature of the surroundings of the Chapel, being a cemetery open since 1846, must be considered. There are many hazards present by the very nature of the ground and gravestones, some of the latter being unsteady and heavy. If these are disturbed / damaged, they may pose a risk to other cemetery users as much as to those causing that disturbance. As well as members of the public who use the cemetery for recreation, there are those including Council employees / contractors and members of the volunteer group 'Friends of Southampton Old Cemetery' (FoSOC) who regularly work on site. From the application, while I understand the focus on business events between 6-8 pm, there is clearly much latitude and scope for longer and later event durations.

On the ground of public nuisance, this again is a situation where the best and worst cases can differ widely. At best, in accordance with brief, early evening events, it may be very limited, but for later and longer events — as would be permitted — this could be more serious. I myself have conducted walks in the cemetery for birds and bats (as part of FoSOC) and these would certainly be disrupted by noise and perhaps light from the Chapel, as they sometimes necessarily take place in early evening. Others lead walk and talks on other subjects, at various times of day. In this matter I broadly interpret 'public nuisance' as anything that may disrupt activities such as those I've described which are part of the accepted recreational use of the Old Cemetery. In a wider interpretation, it may include activities that are out of character with the other aspects of the location, such as in a cemetery, where the mood should remain one for reflection, quiet recreation and respect.

With regard to the question I mentioned earlier, this would continue the concerns I have as stated in the preceding paragraph. The guidelines for comment make no allowance for the disruption caused to an important wildlife site within Southampton, as opposed to objections regarding people. In locations such as the Old Cemetery, I feel this is important and would appreciate the opportunity to emphasize this: please could you inform me of

the appropriate channel for further expressing such a concern.



- 1. **Timing:** This application has only very recently been drawn to the attention of the synagogue through unofficial channels. Given the proximity of the closing date for representations, this document has therefore been drawn up with some haste, and the case is to some extent incomplete. We are disappointed that the Licensing Authority was not in touch with us directly, as we are clearly an interested party, as discussed below.
- 2. **Scope of objections:** These representations relate to points of general concern, and also points which concern the synagogue specifically.
- 3. Cemetery environment: The premises concerned lie inside the grounds of the Old Cemetery. A cemetery is a place of commemoration for the dead, and in many cases (including ours) contains places regarded as sacred. The proposed licensing hours include times at which visitors may be expected to be visiting the graves of deceased relatives. In the absence of stringent mitigating measures, music and the possible presence of intoxicated persons will have the effect of changing the character of the area.
- 4. Old Jewish Cemetery: The premises in question lie within 50 metres of the Old Jewish Cemetery. The last burial in these grounds took place in 1974; the synagogue currently uses a dedicated "new" area in the Hollybrook Cemetery on Tremona Road. However, present and former members of the community regularly visit graves in the "Old Cemetery". One of the chapels in this cluster (not, we believe, the premises for which an application has been made) was formerly the chapel used for Jewish funeral prayers. The Old Cemetery is in addition of significant historical interest.
- 5. Possible Desecration of Jewish graves: The Licensing Team should be aware that for Jewish Communities low levels (and sometimes not so low levels) of anti-Semitism unfortunately remain a continual problem. One manifestation of this antipathy towards Jews and Judaism is "desecration of graves". In less serious cases, this involves daubing of graves with paint, and sometimes neo-Nazi slogans, and in more serious cases, involves wholescale uprooting of graves. This can cause not only distress, but also considerable restoration costs. Unfortunately there have been such occurrences in Southampton, in both the New and Old Cemeteries. The Old Cemetery suffered a particular serious

attack in 1991. The upshot was (a) there was a gratifying outbreak of public support (including an "anti-racist Demonstration" in our support), and (b) the entry to the Old Cemetery was reduced in size. The hedge surrounding the Old Cemetery is now rather high, and the entry is very discrete, in such a way that (it was felt) that only visitors searching for a Jewish cemetery would be able to find it.

However, if (essentially) a Public House is located less than 50 metres away from the Jewish Cemetery, these mitigating factors would probably no longer apply. We are of course not accusing the usual patron of a Southampton licensed establishment of either drunkenness or anti-Semitism. We merely say, that if there were an anti-Semitic individual who became intoxicated, our Cemetery would be a natural target. Although there are few such individuals, when one considers time periods of years the likelihood of this occurring becomes very high. For us the price of this (relatively rare, but ever-present) event would likewise be very high. Consequently this is a risk we would really prefer not to have to address.

6. Planning considerations: We are aware that the Licensing Team does not explicitly deal with planning matters. However, we respectfully suggest that this application involves a planning element. As such, we think that the application should also be considered by the relevant team. We focus the specific question by going back in time to the planning decision for change-of-use of the chapel buildings. Suppose that at that time, the proposal had been to turn one of the chapels into a public house. We venture to suggest that the proposal would have offended public decency, and would have been rejected out of hand.

I or another senior member of the Jewish Community would be happy to appear in person to explain and amplify our concerns.

#### **Dear Licensing Team**

I am writing to oppose the above application in my position as both a citizen of Southampton but also as the secretary of the South Hampshire Reform Jewish Community which has its origins and deep roots in Southampton.

At a general level this is unacceptable as the old cemetery is a much-loved space of calm and reflection in the city and provides immense benefit to Southampton in this respect. It is for many also a sacred space and of deep spiritual importance to so many of its people.

The old cemetery is of immense historical and social significance and people of all faith and none are buried here. In this particular objection, I would point to the old Jewish cemetery which is very close to the old chapel for which this application is focused. Whilst the old Jewish cemetery is overseen by the Southampton Hebrew Congregation, we have members in common who are buried there, so have a particular concern.

The old Jewish cemetery is one of the oldest in the UK and has especial historical importance, reflecting unique experiences. It has been subject to antisemitic vandalism on numerous occasions. In 1991 every tombstone was covered in Nazi style graffiti which gained much public protest and disgust. Less well known have been irreparable damage to many tombstones in a series of attacks. The proximity of the chapel, alongside the sale of alcohol over a long period would make the Jewish cemetery extremely vulnerable. The Council has a duty of care to make sure that the Jewish cemetery is kept from harm and if approved, this application would put it at risk. This would be against all the council's commitment to diversity and inclusion.

Thus for both general reasons of the public good and the specific need to protect the Jewish community and its heritage, I urge you to turn down this application.

This application has only just come to our notice since there is just a small grubby sign on a post which is easily missed, hence this last minute email.

I wish to object to the granting of this license for the following reasons:

These premises are in a CEMETERY for goodness sake, which is an entirely inappropriate place for a drinking and music making establishment. Even though most of the graves are very old, there are still occasional burials there and just through the arch to the left is a new area set aside for interment of ashes. People who come for an interment or to visit the graves of family members expect a peaceful place for reflection and it is heartless that they should have to put up with music and noise from this chapel.

The premises face right on to the war memorial and the grassed area surrounding it. This is where a remembrance service is held each year. It is inevitable that visitors who have been drinking will spill out into this special area.

# Procedure – Applications etc. under the Licensing Act 2003 or Gambling Act 2005

- A hearing will be held to decide applications, etc., under the Licensing Act 2003, where
  there have been relevant representations from one or more of the responsible
  authorities or other persons. The parties to the hearing will have the chance to be heard.
  They are also entitled to be helped or represented by another person if due written
  notice is given in advance.
- 2. Hearings will take place before a Sub-Committee comprising three members of the Licensing Committee. One of these members will be elected Chair of the Sub-Committee for that hearing.
- 3. Please note that for day time hearings the Sub-Committee will normally adjourn for lunch at 1:00 p.m. and that comfort breaks will be taken at the discretion of the Chair at appropriate points during the meeting.

#### **Preliminary matters**

- 4. The Chair will introduce those present.
- 5. The Chair will check whether any of the Sub-Committee members has a "disclosable pecuniary", "personal" or "pecuniary" interest.
- 6. The Chair will check whether all the parties are present at the hearing, and if any are not, whether they have told the Council that they do not wish to attend or be represented. If any party who was expected to attend has not done so, the Sub-Committee will decide whether to hold the hearing in that party's absence, or to adjourn it to another date. Hearings will be adjourned if the Sub-Committee considers this necessary in the public interest, if that is possible. If the Sub-Committee decides to hold the hearing in a party's absence, they will still consider any written information received.
- 7. In the case of an application for variation or a new licence, the Sub-Committee's legal advisor will ask the applicant or their advisor for confirmation that the required public notices have been displayed where they can conveniently be read from the exterior of the premises and that notice was given in a local newspaper within eleven working days of the day on which the application was received by the licensing authority.
- 8. Normally, hearings will be open to the public. However, the Sub-Committee may exclude the public from the hearing (or part of it) if they think the public interest in doing so outweighs the public interest in having the hearing in public. If the public are excluded, any of the parties to the hearing, and/or anyone helping or representing them, may also be excluded.
- 9. The Chair will propose a motion that the public and the press be excluded from the hearing while the Sub-Committee considers the matter. Ordinarily the legal advisor and democratic support officer will remain (see paragraph 30 (b) below).
- 10. The Openness of Local Government Bodies Regulations 2014 provide an entitlement for the public to film, photograph and audibly record ("record") public meetings. However, by virtue of Schedule 6, paragraph 58 of the Licensing Act 2003 and section 101 (15) of the Local Government Act 1972, Licensing Act 2003 hearings are not covered by the entitlement to film as of right. The Council's general approach is to encourage openness and transparency in all its dealings and the general presumption is that filming or recording of hearings shall generally be permitted where due notice has been provided in advance of the hearing. Nonetheless the following shall apply:



- i) Filming / recording / photographing hearings shall only be permitted with the express permission of the Chair. Such permission may include restrictions to protect children, vulnerable persons or others that object to being filmed / photographed / recorded.
- ii) Requests to film / record / photograph should be made with sufficient notice in advance of the hearing. Late requests may not be granted if there shall be a delay to proceedings as a result.
- iii) Every party to the hearing and any witnesses shall have the opportunity to object and those representations shall be considered by the Sub-Committee.
- iv) No filming, photography or sound recording shall be permitted of any person under 18 years of age.
- v) No person shall be put under any pressure to consent to such and no payment for such consent shall be given.
- vi) The Chair shall have the final say as to whether any filming, photography or recording is allowed (including the extent to which permission is granted e.g. the parts of the meeting, the individuals concerned or the arrangement of the recording equipment).
- vii) All directions given by the Chair shall be fully complied with and the Chair shall have the absolute discretion to withdraw permission to film, photograph or record in the event the same causes an obstruction or interferes with the general conduct of the hearing, including the impeding of the giving of proper evidence.
- 11. A party may have asked for someone else to appear at the hearing to make a point or points that may help the Sub-Committee reach a decision. It is up to the Sub-Committee to decide whether that person should be heard, although permission will not be refused unreasonably. Such a person is referred to as a "witness" in this procedure.
- 12. Where application has been made, in advance of the hearing, that it should be conducted in private (e.g. by the Police in review or summary review proceedings) reports shall be prepared and presented as confidential so that the Committee can make a meaningful determination in accordance with Regulation 14 of the Licensing Act 2003 (Hearings) Regulations 2005 to exclude the press and public. It is important to note that reports presenting Licensing Act 2003 matters are not required to be published in advance. However, certain limited information must be published in accordance with the Licensing Act 2003 (Licensing Authority's Register) (Other Information) Regulations 2005 and section 8 of the Licensing Act 2003.
- 13. The Chair will then explain the procedure that will follow.

#### General information on the conduct of the hearing

- 14. Each party is entitled to:
  - (a) Give further information in response to any point that the Council told them before the hearing they would like clarified;
  - (b) With the permission of the Chair, seek clarification on any point by any other party;
  - (c) Address the Sub-Committee.
- 15. Members of the Sub-Committee may also seek clarification of any party or witness.
- 16. At the Chair's discretion, the Sub-Committee's legal advisor may ask any questions he or she thinks are relevant.



- 17. Unless the Council has requested in advance that a particular point be clarified, new documentary or other evidence may not be submitted for the first time at the hearing, unless all the other parties agree.
- 18. Members of the Sub-Committee will have read all the papers included in the agenda for the hearing before the hearing starts. The parties are requested not to spend unnecessary time repeating evidence which is already in the papers and which is not disputed.
- 19. Evidence that is not relevant to the case, or to the promotion of the four licensing objectives, will be disregarded.

## **Hearing Procedure**

- 20. If any party has asked permission for a witness or witnesses to appear, the Sub-Committee will decide whether they should be heard (see paragraph 10 above).
- 21. All parties will be allowed a similar (and maximum) amount of time to put their case, and ask questions of other parties, subject to the Chair's discretion to not hear repetitive matters or questions.

#### The applicant

- 22. The applicant for the licence (or their representative) or the applicant in review proceedings, may present their case.
- 23. If the Sub-Committee permits, the applicant may call those witnesses whose names have been provided in advance to support their application.
- 24. Where a group of witnesses wish to speak in support of the application for similar reasons, one person should, where possible, act as spokesperson for the whole group. The Sub-Committee may reasonably refuse permission for a witness to be heard if their evidence simply repeats points already made.
- 25. The Chair will invite those making representations to seek clarification on any point made by the applicant. The Chair will decide in which order those making representations will be invited to put their questions.
- 26. Members of the Sub-Committee or the Legal Advisor, if so permitted by the Chair, may also seek clarification of the applicant or any of their witnesses.

#### The representations

- 27. Where there is more than one person making a representation, the Chair will decide the order in which they may put their case. If there is a representation from one or more of the responsible authorities, their representatives will normally be invited to put their case first.
- 28. The following procedure will apply to each person making a representation in turn:-
  - (a) The person making a representation (or their representative) may present their case.
  - (b) If the Sub-Committee permits, the person making a representation may call those witnesses whose names have been provided in advance to support their objection.
  - (c) Where a group of witnesses wish to speak in support of the objection for similar reasons, where possible, one person should act as spokesperson for the whole group. The Sub-Committee may reasonably refuse permission for a witness to be heard if their evidence simply repeats points already made.



- (d) The Chair will invite the applicant to seek clarification on any points made by those making representations.
- (e) Members of the Sub-Committee or the Legal Advisor, if so permitted by the Chair, may seek clarification of those making representations or any witnesses.

#### Summing up

- 29. The Chair will invite each person making a representation to make a final statement or sum up their case.
- 30. The Chair will invite the applicant to make a final statement or sum up their case.

#### **Sub-Committee's decision**

31.

- (a) At the end of the hearing the Sub-Committee will move to private session whilst it considers the matter.
- (b) The Sub-Committee's legal advisor will remain to provide legal advice and the democratic services officer will remain to record the decision. Details of any legal advice will be recorded and referenced in the decision and reasons.
- (c) The parties will be invited to wait to be informed of the outcome.
- (d) As soon as the decision is reached, the public and press will be invited to return to the room in which the hearing took place, and the Chair will announce the decision and the reasons for it.
- (e) If a room is available, the Committee may retire to deliberate and make its decision
- (f) All parties will be formally notified in writing of the decision and reasons as soon as possible.

In most cases the Sub-Committee will announce the decision at the conclusion of the hearing. In certain cases where this is not possible due to time constraints (and the Hearings Regulations permit – Regulation 26 (1) sets out those hearings where delay is not possible) the decision shall be made within 5 working days beginning with the day of the hearing or the last day of the hearing.
