Equality and Safety Impact Assessment

The **public sector Equality Duty** (Section 149 of the Equality Act) requires public bodies to have due regard to the need to eliminate discrimination, advance equality of opportunity, and foster good relations between different people carrying out their activities.

The Equality Duty supports good decision making – it encourages public bodies to be more efficient and effective by understanding how different people will be affected by their activities, so that their policies and services are appropriate and accessible to all and meet different people’s needs. The Council’s Equality and Safety Impact Assessment (ESIA) includes an assessment of the community safety impact assessment to comply with section 17 of the Crime and Disorder Act and will enable the council to better understand the potential impact of the budget proposals and consider mitigating action.

<p>Name or Brief Description of Proposal</p>	<p>Development of an integrated prevention and early help offer for children aged 0-19 and their families</p>
<p>Brief Service Profile (including number of customers)</p>	<p>There are approximately 54,000 children and young people aged 0-19 living in Southampton. The prevention and early help services included in this proposal range from some universal services open to potentially all, to a more targeted form of more intensive support that would only apply to children and young people with additional needs, or whose home life makes them vulnerable to poor outcomes. It would combine the following local services: Children’s Centres, Health Visiting, School Nursing, Families Matter and Family Nurse Partnership. The new integrated service would work both directly with families and indirectly through its work with other services and organisations and professionals working with children, young people and families, such as maternity services, pre-schools, schools, colleges, GPs, children’s social care services, services for children with Special Educational Needs and/or Disability (SEND), Child and Adolescent Mental Health Services (CAMHS), and a host</p>

	of local community and voluntary sector organisations whose services also support these communities.
Summary of Impact and Issues	<p>The proposed integration of these services is anticipated to have positive impacts upon children and young people through providing a more streamlined, coordinated service offer. The integration of these services will also better equip them to deal with further reductions in funding should these happen as a result of changes in:</p> <ul style="list-style-type: none"> • local authority funding (as outlined in the Council's budget consultation proposals for 2017/18 to 2020/21), • funding for elements of the current services currently funded by central government grant and/or • changes in the contribution made by schools to these services arising from changes to schools' funding made nationally. <p>The proposal describes an approach that will create opportunities for service efficiencies by integrating management, processes and back office functions and more joined up working across health and social care staff.</p>
Potential Positive Impacts	<p>This proposal has been developed as part of a positive transformation of a range of services intended to improve the capacity and resilience of children, young people and families in Southampton to cope successfully with the challenges of life. Integration of these services will achieve this through all of the services more truly working towards a shared and consistent set of priorities for the whole service in relation to the City's 0-19 year olds. It acknowledges that current systems for support are fragmented and confusing and that there are too many pathways and different teams; too many "front doors" and too many examples of services "not talking to each other</p>

	<p>or giving conflicting messages". Health and social care services work out of over 30 different buildings across the system, using IT systems which do not enable information to be shared electronically. The lack of a clear and easy route into early help has led to overuse of the MASH and referrals into Children's Social Care in the absence of other escalation routes, resulting in wasted efforts without positive outcomes for families.</p> <p>By fully integrating services the city would be able to achieve:</p> <ul style="list-style-type: none"> • a coordinated offer of support; • more efficient and effective processes; • potential rationalisation of buildings usage and organizational infrastructure; • improved training and whole workforce planning; • improved consistency and efficiency of management and supervision; • improved accountability • a new culture of integrated working and joint ownership of health, social care and educational outcomes, regardless of organisational background
