### THE DECISION

To approve the proposed Evening Parking Charges for implementation.

### REASONS FOR THE DECISION

To manage demand for parking during the evening period.

To encourage drivers to use alternative transport modes for the benefits of reduced congestion and improved air quality

### DETAILS OF ANY ALTERNATIVE OPTIONS

To not implement the Evening Parking Charges, as this would not achieve the aim of these proposals.

To implement the proposal in part, as this would have to be justified on the basis of traffic management reasons, especially given the likelihood of displacement of parking from the areas where the charges were implemented

To defer implementations of the proposals, as material considerations such as the levels of parking demand, may have changed within an extended timeframe, which may warrant a further investigation/consultation

### OTHER RELEVANT MATTERS CONCERNING THE DECISION

Cabinet considered the following recommendations from Overview and Scrutiny Management Committee held on 8th September, 2022

- (i) That the Executive reconsider the proposed introduction of evening parking

- charges at the September 2022 Cabinet meeting (postponed to 18th October 2022 due to the period of national mourning for Queen Elizabeth II). Recommendation rejected by Cabinet.
- (ii) That, if Cabinet agree to introduce evening parking charges, the findings from the proposed 4 month post implementation review are presented to the Committee. Recommendation accepted by Cabinet.
  - (iii) That, if Cabinet agree to introduce evening parking charges, the proposed post decision analysis includes metrics that seek to measure the impact on city centre trade as a result of the introduction of evening parking charges. Recommendation accepted by Cabinet.
