BRIEF SUMMARY

Southampton SACRE convened an Agreed Syllabus Conference in Summer 2015 to begin the process of revising the Locally Agreed Syllabus that had been in place since 2011. This has been carried out successfully and on 19th September the SACRE met and approved the new syllabus "Living Difference III" subject 2016 advice from Legal Services. Therefore the SACRE recommend the Council should require its use in all maintained Southampton Schools (with Voluntary Aided schools being the exception). SACRE members, Council officers and teachers worked together with colleagues from Hampshire, Portsmouth and the Isle of Wight to undertake the review as the syllabus is shared by all.

RECOMMENDATIONS:

(i) To accept the revised Locally Agreed Syllabus for Religious Education and require its use in all Southampton maintained schools, except those who are Voluntary Aided, from January 2017. This is as a result of the approval of the syllabus by Southampton SACRE on 19/9/2016 who recommend it to the Local Authority.

REASONS FOR REPORT RECOMMENDATIONS

- 1. Southampton SACRE have ensured that the syllabus has been revised in accordance with the statutory responsibility that they must require the LA to revise it every 5 years, or more regularly if required.
- 2. SACRE members, Council officers and teachers have revised the syllabus over the past year following consultation with schools in conjunction with colleagues from Hampshire, Portsmouth and the Isle of Wight.

ALTERNATIVE OPTIONS CONSIDERED AND REJECTED

- 3. As the syllabus was approved and is recommended to the Council for use in all maintained schools in Southampton that are not Voluntary Aided, no other options need to be considered.
- 4. If it was not approved, Southampton SACRE would have needed to develop

another syllabus or adopt a different syllabus from another SACRE. It was decided that the syllabus was effective and therefore to review the existing syllabus given its basis in academic theory.

DETAIL (Including consultation carried out)

5. Consultation carried out comprised the following:

June 2015 – city wide schools consultation proposing areas of review and improvement.

July 2015 – Review Group established across all partners

September 2015 - May 2016 - four writing days to review and rewrite

April - June 2016 - selected schools consulted on draft changes

July 2016 – Review Group agrees the final revisions

August – September 2016 document prepared for publishing

September 19th Southampton Agreed Syllabus Conference recommends the new syllabus "Living Difference III" to the Council for use in all maintained schools (with the exception of Voluntary Aided schools).

6. Key changes have taken into account the recommendation from the High Court Ruling R (Fox) v Secretary of State for Education [2015]: to ensure that the Locally Agreed Syllabus includes Key Stage 4 coverage of non-religious world views where there may not be covered within GCSE Religious Studies syllabi. It has also reviewed how Religious Education can be assessed by considering the skills of enquiry that should be demonstrated in line with current wider educational practice. This ensures that school will be able to assess progress within the skills of enquiry more in line with other national curriculum subjects

RESOURCE IMPLICATIONS

7. Resource implications are that:

Costs had already been allocated within existing budgets for the launch and training. There is currently no cost for the immediate solution for a web presence. However the area within the site will be hosted on "Young Southampton" is under review and therefore this may not be a long term solution depending upon the outcomes of this review within digital transformation.

Capital/Revenue

- 8. Southampton SACRE has an existing budget allocation to launch the syllabus and offer four training sessions for teachers to ensure it is implemented effectively in all schools. Working in conjunction with other Council's and SACREs has enabled savings in the number of days required to revise the syllabus as the work has been shared between those involved in the review.
- 9. Southampton SACRE is currently exploring costs with officers in the School Improvement team fund the development of a website/space to host the syllabus for promotion to schools, ease of access for teachers and to host the resources that support the delivery of the syllabus. This web presence is important as Southampton SACRE does not have budget to produce hard copies of the syllabus for all schools, as had been the case for the 2004 and 2011 syllabi.
