DETAIL

5 The priorities for Member learning and development were detailed in the

Member Development Strategy 2009-2012 and related Action Plan (Appendix 1).

- 6. An internal audit review of Member development has recently taken place in relation to the Annual Governance Statement. The report is currently being finalised and it is expected that the recommendations will be available for consideration at the Standards and Governance meeting.
- 7. Whilst there were no local elections in May 2009, two new Cabinet Members were appointed by the Leader of the Council in June and an induction programme was developed by senior officers in Children's Services and Learning in liaison with Members' Services. The programme included personal development planning, IDeA peer mentoring and the opportunities to attend relevant courses and seminars, as well as in-house training, briefings and visits to services and schools.
- 8. During the year, Chairs of committees have strengthened their involvement in the training and development of committee and other members. As an example, the Chair of Planning and Rights of Way Panel introduced a programme of short training session to follow on from panel meetings and this has now been incorporated into the Member Development programme for 2010-2011. Other training recommended by Cabinet Members and Chairs of Committees has also been included in the programme, in particular sessions on Safeguarding Children and Corporate Parenting and a CIPFA workshop on understanding local government accounts (outline programme for 2010-2011 included as Appendix 2)
- 9. The level of attendance at training sessions can vary depending on the topic, timing and Members' experiences and commitments. Concerns have been raised about low attendance at some specific sessions and ways to enhance attendance will be discussed at the next meeting of the Member User Group.
- 10. Members of Standards and Governance Committee are invited to comment on any aspect of Member learning and development, including recommendations to be included in the revised Member Development Strategy.
